2020/21 Application for Residential Property Tax Relief

A partial residential property tax reduction for the 2020/21 taxation year is available to residential property taxpayers whose total household income is less than \$22,310. and the property is occupied by the applicant taxpayer as his/her principal residence. The amount of the exemption is based on the following income scale to provide greater assistance to lower income families:

<u>Income</u>	<u>Exemption</u>
\$19,123. or less	\$500.
\$19,124. to \$20,185.	\$400.
\$20,186. to \$21,247.	\$300.
\$21,248. to \$22,310.	\$200.
over \$22,310.	No Exemption

- Your completed application form must be received by **September 30, 2020**. **Late applications will not be considered.**
- Your application will be considered to determine whether you qualify for Residential Property Tax relief. ***You will be notified of the results of your application .***
